THE PURCHASER AGREES TO THE FOLLOWING:

Limited Guarantee: The Seller guarantees that the cat is in good health at the time of purchase.

It is suggested to isolate the Exotic Shorthair / Persian kitten from all other animals until examined by a veterinarian and deemed healthy. Your kitten must be examined within 3 business days from the date of pick up for the limited guarantee. If the above Kitten is examined and is found to have a serious health condition, the Seller will provide a replacement of the same quality or refund per the seller's discretion.. The seller will only guarantee Feline Leukemia (FELV) for the first 3 days. If the Exotic Kitten is found to have a serious health condition, the Purchaser must provide documentation from your veterinarian and confer with my consulting Veterinarian. We never pay your Veterinary bills ever. Please consult prior to any Veterinary visit.

Vaccination: FVRCP- Leuk and worming with Piperazine, Date

DVM Heins Rupert Animal Clinic 208-436-9818 Your kitten will have a Vet. health exam and a vaccination history will be provided at pick up.

Vaccinate your kitten 3- 4 weeks after the above date, then follow your Veterinarians Vaccination Protocol.

Health Guarantee: The Seller further guarantees against lethal genetic or congenital defects for the first 18 months from birth, and FIP for one (1) year from date of birth, with the understanding that the Purchaser agrees to take Cat for a yearly veterinary examination and will provide yearly three-way vaccinations and (rabies, if required by law), or all health guarantees will be void. If Exotic cat should die due to a genetic or congenital defect in the first 18 months from birth, or be put to sleep due to FIP during the first year from birth, the seller agrees to replace the Exotic kitten or cat with the next available cat of like quality when available, upon being provided with a necropsy (autopsy) report from a licensed veterinary pathologist. The report must state that death was unquestionably a genetic/congenital defect or FIP. Purchaser agrees to forward the autopsy report by a licensed veterinary pathologist, including full medical and vaccination history to the Seller's veterinarian. All cat costs including vet bills, shipping and transportation are the sole responsibility of the Purchaser at all times. Purchaser is responsible for the health certificate and transportation of the replacement kitten. If obtaining a replacement kitten, Seller cannot guarantee the same color/pattern/gender, but will try to accommodate all preferences. Buyer understands if a specific color, pattern, or gender is wanted, that it may take time to receive a specific kitten. Purchaser understands and agrees that no monies, including the deposit, will be refunded at any time
